4. The Financial Proposal shall invariably be accompanied with Bid Security @ 2% of bid cost (Refundable) in the form of a bank draft/CDR drawn in the name of **The University of Shangla fee collection account**, Account number: **3005714353**.
5. The bidders shall clearly and boldly mark the Tender description and date/time of opening at the face of the sealed bid/envelope.
6. Bids submitted without the prescribed Bid Security shall be liable for rejection at the time of bid opening.
7. Technical Proposal opening will be held in the Committee Room of the University of Shangla in the presence of the bidders and the University Purchase Committee (UPC), as per the schedule above.
8. The University of Shangla reserves the right to reject any or all bids in accordance with the rules in vogue.
9. The firm must have a valid NTN, Sales Tax (GST/KPRA) registration, and Active Taxpayer List (ATL).
